Once the online option is disabled, all registrations must be submitted manually by walking in a completed registration form to the Program Coordinator at your preferred location. If the program has already begun, then it is best to contact the site phone listed on each calendar, before waling-in to the site. The acceptance of walk-in registrations is ultimately determined by the Site Coordinator and is contingent on space availability. All program activities are planned in advance, and there may be instances in which we cannot change the reservation or may not have enough space on the bus to accommodate additional students. While we will do our best to work with every family, there is no guarantee that all walk-in registrations will be accepted.
